

Corona discharge treatment is available on either the inner or outer surface of Encore RFC  $r_{30}$ .

The treated surface is indicated by a symbol on a label attached to each reel.

#### Film Storage and Handling

Care should be taken to protect reels of film from storage temperatures above 30°C (86°F) and localised sources of heat above 45°C (115°F). The reels should remain in the protective coverings supplied until ready for use on converting machinery. Converted reels, in both master and slit reel form should be similarly protected at all times. Encore RFC r<sub>30</sub> is suitable for use for 6 months from the date of delivery and stocks should be used in rotation. Films should be allowed to reach operating room temperatures for 24 hours before use.

#### **Food Contact**
