#### **Technical Properties (Typical Values)**

**RCU25/30/35/40** are designed for VFFS, HFFS and overwrap formats where optimum product presentation is required. The films' barrier properties make them particularly suitable for bag in box applications, such as: biscuits, cereals, confectionery and dried foods.

**RCU52/60** are suitable for heavy duty applications where the films' excellent hot-tack and seal threshold can give superior machine performance over alternative structures.

#### Film Storage and Handling

The low heat-seal threshold and wide seal range of Propafilm<sup>™</sup> RCU film allows its use in particularly demanding packaging machine applications. Care should therefore be taken to protect reels of film from storage temperatures above 30°C (85°F) and localised sources of heat above 45°C (115°F). Reels of Propafilm<sup>™</sup> RCU should be protected from high levels of moisture and accidental water splashes at all times. The reels should remain in the protective coverings supplied until ready for use on converting or packaging machinery. Converted reels, in both master and slit reel form should be similarly protected at all times. Propafilm<sup>™</sup> RCU is suitable for use for 6 months from the date of delivery and stocks should be used in rotation. Films should be allowed to reach operating room temperatures for 24 hours before use.
